For example, if you earn Points on December 15, 2020, they will expire at the close of business on December 31, 2021. The oldest accrued Points will be used first for redemptions. You can view and track your Points balance and available Rewards, as well as any additional benefits for which you are eligible as a NUG Rewards Program member by using the App or the Web App.

From time-to-time, NUG may, at its sole discretion, offer incentives to customers to delay expiration of Points. For example, NUG may offer to delay expiration of Points if the user performs a certain task (e.g, writes a product review) or makes an in-store purchase. Such offers will be communicated in NUG stores and/or at www.nug.com.

REDEEMING POINTS FOR REWARDS

DUE TO THE COMPLEX LAWS AND REGULATIONS GOVERNING NUG’S BUSINESS, WE ARE UNABLE TO GIVE FREE REWARDS PRODUCTS TO CUSTOMERS. INSTEAD, UPON REDEMPTION OF POINTS, CUSTOMERS WILL BE CHARGED \$0.01 USD FOR EACH REWARDS PRODUCT.

Points may be redeemed for promotional items (i.e., Rewards) at participating NUG stores in the United States or through our App or Web App. The NUG Rewards Program offers different Rewards based on various Point redemption tiers. Note that the Rewards available and Point redemption tiers may vary by location, and that NUG may adjust the tier levels and the items included in each tier at any time in its sole discretion.

See below for example Point tiers and redemption. Actual tiers will be clearly displayed with the App and Web App.

Example Tiers (for informational purposes only):

<i>Tier</i>	<i>Points Required</i>	<i>Rewards Products</i>
<i>Tier 1</i>	<i>100</i>	<i>Products \$1-\$10 in value</i>
<i>Tier 2</i>	<i>200</i>	<i>Product \$10.01-\$20 in value</i>
<i>Tier 2</i>	<i>300</i>	<i>Products \$20.01-\$30 in value</i>

Example Redemption (for informational purposes only):

A customer has 250 Points. The customer is eligible to redeem Points for rewards as follows:

Scenario 1: Redeem 100 Points and receive one Rewards product from Tier 1. Customer will have 150 Points remaining and will be moved into Tier 1 after redemption. Customer will be charged \$0.01 for the Rewards Product.

Scenario 2: Redeem 200 Points and receive two Rewards products from Tier 1. Customer will have 50 Points remaining and will not be eligible to redeem in any Tier after redemption until additional Points are earned. Customer will be charged \$0.02 for the Rewards Products.

Scenario 3: Redeem 200 Points and receive one Rewards product from Tier 2. Customer will have 50 Points remaining and will not be eligible to redeem in any Tier after redemption until additional Points are earned. Customer will be charged \$0.01 for the Rewards Product.

REDEEMING POINTS FOR CASH VALUE

The NUG Rewards Program may allow customers to redeem Points for “cash value” to be applied towards a purchase. NUG reserves the right to alter the Conversion Rate from Points to dollars. NUG also reserves the

right to limit the minimum and maximum number of Points that may be converted. The fact that the NUG Rewards Program may allow for such conversion in no way attributes an actual cash value to Points.

REDEMPTION AVAILABILITY MAY VARY

Not all NUG stores have the ability to honor Point redemption or provide Point redemption at multiple tiers. Additionally, the items available for redemption in each Point redemption tier may vary by Store. Certain NUG stores may offer only the first Point redemption tier. At such locations, and notwithstanding anything to the contrary in these Terms of Use, you will be eligible to redeem Points for items within that tier only.

ADDITIONAL BENEFITS OF NUG REWARDS

As a NUG Rewards Program member, you may be eligible for the following additional benefits. For example, additional benefits may include:

- Birthday Reward.
- Early or extended access to certain promotions and offers.
- Personalized offers and coupons (“Special Offers”).
- Bonus Points.

Special Offers may be distributed by email, through the App (including via push notifications), or by physical mail. You may be required to opt-in and activate Special Offers via the App or via email. In order to receive and activate personalized Special Offers distributed via email, you must opt-in to receive promotional and marketing offers from NUG and you may be required to provide a valid email, telephone and physical address. Special Offers may be customized based on your purchase behaviors and preferences, and may include periodic discounts on food, beverages and merchandise, or the opportunity to earn Bonus Points. Special Offers may have certain restrictions, including expiration dates and short, time-limited redemption periods. Special Offers are personal to you and cannot be shared, copied or transferred. Read each offer carefully for specific details, expiration dates, and limitations and restrictions.

NUG VIP

NUG Rewards Program participants will have the opportunity to achieve NUG VIP status based on their total Points earned. Regardless of whether Points are redeemed or expired, the total number of Points earned by a NUG Rewards Program participant (“Lifetime Points”) will be tracked and displayed within the App and Web App. Bonus Points and Conversion Points are NOT included in the calculation of Lifetime Points. When a NUG Rewards Program participant’s Lifetime Points meet the minimum required level the participant will be granted NUG VIP status. NUG VIP members are eligible for Special Offers, Bonus Points, and additional exclusive benefits.

OTHER IMPORTANT INFORMATION YOU SHOULD KNOW

There are no participation or membership fees associated with the NUG Rewards Program. Points accrued in connection with the NUG Rewards Program are promotional, have no cash value and cannot be redeemed for cash. In addition, your redemption of Points accrued in connection with the NUG Rewards Program cannot be combined with any other offers or discounts, unless otherwise expressly indicated by NUG.

Your Points, Rewards, and NUG Rewards Program account are personal to you and may not be sold, transferred or assigned to, or shared with, family, friends or others, or used by you for any commercial purpose. You may have only one (1) NUG Rewards account that is personal to you.

Without notice to you, NUG reserves the right to suspend your NUG Rewards Program account and/or terminate your account and/or your participation in the NUG Rewards Program if NUG determines, in its sole discretion, that you have violated these Terms of Use or that the use of your NUG Rewards account is unauthorized, deceptive, fraudulent or otherwise unlawful. NUG may, in its sole discretion, suspend, cancel or combine NUG Rewards Program accounts that appear to be duplicative. In the event that your participation in NUG Rewards is terminated, all accrued Points in your account are void. If applicable, your NUG VIP status will also be terminated.

NUG reserves the right to change, modify, discontinue or cancel the NUG Rewards Program, in part or in whole, at any time and in its sole discretion, without notice to you.

Points may be redeemed at participating NUG stores only. Not all NUG stores, including licensees and affiliates, participate in the NUG Rewards Program.

GOVERNING LAW

Any dispute arising from these Terms of Use or your access to or participation in the NUG Rewards Program will be governed by and construed and enforced in accordance with the laws of California, without regard to conflict of law rules or principles. The United Nations Convention on Contracts for the International Sale of Goods shall have no applicability. Any dispute between the parties that is not subject to arbitration or cannot be heard in small claims court will be resolved in the state or federal courts located in Alameda County, California.

SEVERABILITY

If any provision or part of a provision of these Terms of Use is unlawful, void or unenforceable, that provision or part of the provision is deemed severable from these Terms of Use and does not affect the validity and enforceability of any remaining provisions.
